The following must be attached to this Application:

1. **Pavement and curb cuts.** Diagram showing the dimensions and exact location of the proposed pavement or curb cut as required by Sec. 38-111 of the Code. Applicant must also file a bond with the City Clerk as required by Sec. 38-113 of the Code.
2. **Driveway construction, repair or replacement.** Diagram showing the dimensions and exact location of the proposed driveway work. A sample diagram is attached to this Application. The Applicant should indicate on the diagram where the work will be done.
3. **Street boring.** Diagram showing the exact location of the proposed bore.
4. **Other interference with streets.** Diagram showing the dimensions and exact location of the proposed work. Note that such interference requires approval by the City Council by resolution or ordinance. The applicant may be required to submit additional information requested by the Director of Public Works and the City Council at the time of the City Council hearing.

Driveways and street boring. This Application will be considered officially submitted and filed only after it is examined by the Public Works Clerk and found to have met the applicable requirements of the Code and those set out in this Application and after all City and State fees associated with the permit have been paid.

Pavement, curb cuts and other interference with streets. This Application will be considered officially submitted and filed only after it is examined by the Director of Public Works and found to have met the applicable requirements of the Code and those set out in this Application and after all City and State fees associated with the permit have been paid and a bond has been posted where required. Once the Director of Public Works has found this Application to have met the applicable requirements of the Code, he will direct the Public Works Clerk to set the Application for hearing before the Nichols Hills City Council. The applicant will be advised of the date and time for that hearing. It is highly recommended that the applicant attend (or have a representative attend) that hearing and be prepared to answer questions.

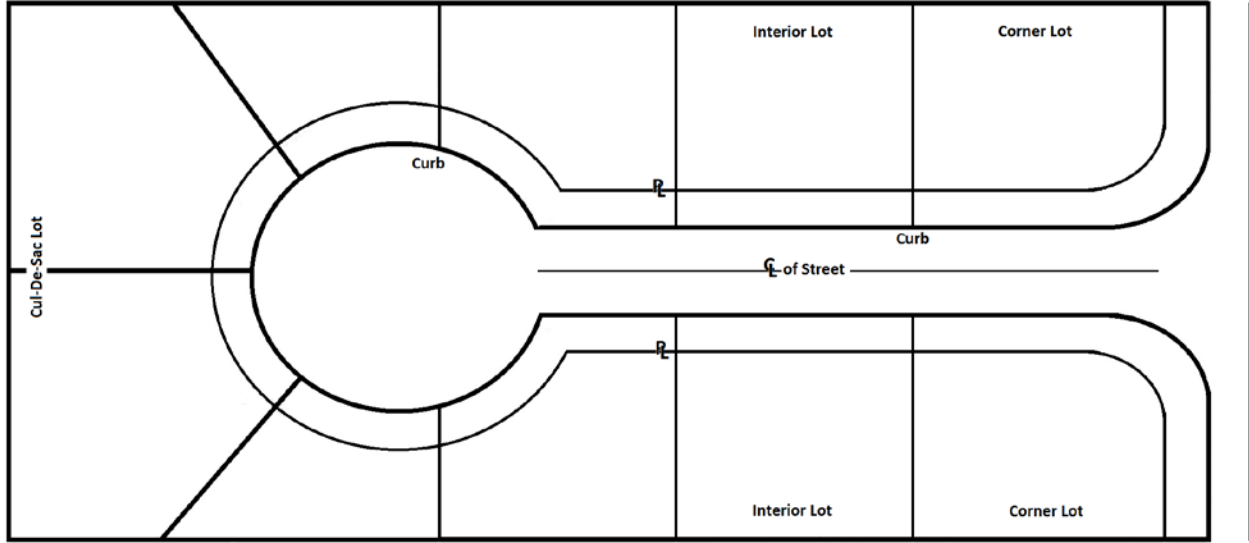
